**18. SPRINT BLOCK OF TIME FOR SMALL BUSINESS****1. Description**

Sprint Block of Time for Small Business<sup>SM</sup> offers small business customers a block of minutes for a flat monthly fee. This block of minutes can be used for certain direct dial outbound and toll free long distance voice services in the interstate, intrastate, and intraLATA jurisdictions. Block minutes will be applied in the following order to qualified domestic Sprint long distance usage: (1) Dial-1 outbound; (2) toll free; and (3) qualified residential Dial-1 outbound and residential toll free long distance. Block minutes cannot be applied to interstate FONCARD, or Switched Data Service (SDS). Each customer may purchase only one block of minutes per month. Except as described in Section 18.8.3 herein, no international usage can be applied to the block minutes. Block minutes will be applied to jurisdictions in chronological order within service types (1), (2), and (3) above. Sprint will charge the customer for any usage in excess of the block minutes (overage minutes) selected at the rates set forth herein. Block minutes that have not been used at the end of customer's billing cycle will not carry over to the next month. The following additional Sprint Block of Time for Small Business Services are available but will not contribute to the block of minutes: FONCARD, Switched Data Service (SDS), and International Toll Free Service. Additional monthly recurring charges (Section 18.7) will apply for interstate and international toll free services and features. Rates for services which are not eligible for the block of minutes are set forth below. Aside from the monthly service charge associated with the applicable block of minutes selected by customer, no minimum usage or term is required. The monthly charges do not include taxes, surcharges, regulatory program charges, local access, operator services, or other applicable non-usage charges. See Section 18.18 herein for additional service restrictions.

**2. Access Options**

Sprint Block of Time for Small Business offers switched access options (including Dial-1 and FONCARD) as described in Section 3.1.2 of [Business Communications and Miscellaneous Services](#)

**3. Billing Increments**

Unless otherwise indicated, all calls will be billed in 60 second increments.

**4. Call Periods**

Rates apply 24 hours a day, every day.

**5. Minimum Monthly Commitment Level**

Aside from the monthly service charge (Section 18.8) associated with the applicable block of minutes selected by the customer, no monthly commitment levels apply.

No Termination Liability applies.

7. Monthly Recurring Charges for Toll Free Service

[Sprint Interstate and International Toll Free Monthly Recurring Charges](#) apply.

8. Monthly Recurring Charges (MRC)

The following monthly recurring charges apply for combined interstate, intrastate, and intraLATA usage. For Options J - M, the interstate MRC includes the intrastate MRC. In order to subscribe to Sprint Block of Time for Small Business, a customer must pay both the interstate MRC and the intrastate MRC.

Options A, J and L\* are available only through Sprint Local Telephone Company in Sprint Local Telephone Company territories. Option M is available only to customers who have received a competitive offer.

1. Except for Calling Plan Option customers (see Section 18.8.3 below), block minutes will be applied first to qualified Domestic (1) Dial-1 outbound; (2) toll free; and (3) qualified residential (NR) (see Section 18.10) usage. Block minutes cannot be applied to Sprint international calls, FONCARD, or Switched Data Service (SDS). Block minutes will be applied to jurisdictions in chronological order with service type (1), (2), and (3) above. Block minutes not used at the end of the customer's billing cycle will not carry over to the next month. Additional minutes for long distance will be rated as shown in .2 below.

\* Effective April 29, 2006, Sprint Block of Time for Small Business Options A, J, and L will no longer be available to new customers. In addition, existing customers will no longer be allowed to make changes to their plans.

2. The following per minute rates apply for applicable interstate minutes above the block:

3. For Calling Plan Option customers (see Section 18.16 herein), block minutes will be applied first to qualified (1) domestic Dial-1 and international Dial-1 outbound to Canada and the United Kingdom; (2) domestic toll free; and (3) qualified domestic residential (NR) (see Section 18.10) usage. Block minutes cannot be applied to Sprint international calls except for dial-1 outbound calls to Canada and the United Kingdom, FONCARD, or Switched Data Service (SDS). Block minutes will be applied to jurisdictions in chronological order with service type (1), (2), and (3) above. Block minutes not used at the end of the customer's billing cycle will not carry over to the next month. Additional minutes for long distance will be rated as shown below. The following per minute rates apply for applicable interstate minutes and international Dial-1 minutes to Canada and the United Kingdom above the block:

9. [Reserved for future use]10. Qualified Residential Usage\*

Customer may elect to have employee usage at satellite locations be subscribed to Sprint Block of Time for Small Business under the Customer's account via Consolidated Invoicing. No more than ten satellite locations' (e.g., customer's employees' homes) usage can be subscribed under the Customer's account. These satellite locations will receive the applicable per minute rates, including block overage rates, associated with Sprint Block of Time for Small Business, as well as the business rates for the Presubscribed Line Charge and Universal Service Charge. Customer will be financially responsible for the satellite locations Sprint Block of Time for Small Business charges.

11. Surcharges

Sprint Block of Time for Small Business FONCARD calls will be assessed a per call [Sprint Block of Time for Small Business FONCARD Surcharges](#).

\* As of May 3, 2008, Qualified Residential Usage is no longer available to new customers.

3. Sprint International Access (Sprint Express)

A Sprint International Access (Sprint Express) per call surcharge of \$1.40 will apply.

3. Troubleshooting Charges

1. By Sprint

2. By Local Telephone Company

A per visit rate equal to charge assessed Sprint by the local telephone company plus a 5% surcharge for administrative expenses.

3. By Vendor of CPE

A per visit rate equal to charge assessed Sprint by the vendor plus a 5% surcharge for administrative expenses.

4. Operator Service

[State-to-State Operator Services Per Minute Rates](#) and [International Operator Services Per Minute Rates](#) apply. Call Placement Charges apply per call.

5. Sprint International Access (Sprint Express)

The [Sprint International Access](#) (Sprint Express) rates apply for FONCARD calls. In addition, a \$1.40 per call surcharge applies. For collect calls, [Sprint International Access Collect Rates](#) apply. In addition, a [Sprint International Access Collect Surcharge](#) applies per call. Country-to-country calls are charge the [Sprint International Access Country-to-Country Rates](#) and a \$1.40 per call surcharge.

14. Interstate Usage Rates

The following rates apply 24 hours a day, 7 days a week. All calls are billed in 60 second increments.

1. Interstate FONCARD

FONCARD interstate service is available from the U.S. Mainland, Alaska, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands. Interstate calls may terminate to a state, U.S. possession or territory that is different from the originating location. Terminating locations include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands, unless otherwise specified in Schedule No. 11.

14. Interstate Usage Rates (Continued)

2. Interstate SDS

The following rate applies to interstate SDS. All calls are billed in 6-second increments with a per call minimum of 18 seconds. SDS interstate service is available to customers in the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands. SDS interstate calls terminate to a state, U.S. possession or territory that is different from the originating location. Terminating locations for SDS interstate service include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands unless otherwise specified in Schedule No. 11.

1. Dial-1 and FONCARD

2. SDS Sprint Block of Time for Small Business<sup>SM</sup> International Outbound Usage Rates

3. International Toll Free Sprint Block of Time for Small Business Inbound Usage Rates

[Sprint Business Flex With All Calls All Day International Toll Free Rates](#) apply.

16. International Calling Plan Option

For an additional \$5.00 monthly recurring charge, subscribers will receive discounted [Sprint Block of Time for Small Business International Calling Plan Option Dial-1 and FONCARD Rates](#) for calls to certain locations. These rates will apply in lieu of [Sprint Block of Time for Small Business Dial-1 and FONCARD International Rates](#).

17. Service Availability

Sprint Block of Time for Small Business is available to customers in the U.S. Mainland, Hawaii, Puerto Rico and the U.S. Virgin Islands. Sprint Block of Time for Small Business is available only to those customers who subscribe as well to the intrastate version of this service offering.

18. SPRINT BLOCK OF TIME FOR SMALL BUSINESS (Continued)

18. Service Restrictions

In order to be eligible for Sprint Block of Time for Small Business service, no more than 30% of the customer's total monthly minutes can be intrastate/intraLATA minutes ("intrastate/intraLATA usage cap"). Sprint will monitor the customer account for abuse of the intrastate/intraLATA usage cap. If a customer exceeds the intrastate/intraLATA usage cap for two consecutive months, the customer will be notified in writing that the customer's service will be switched to Sprint Business Flex with All Calls All Day if the customer exceeds the usage cap in a third consecutive month. Customers that exceed the intrastate/intraLATA usage cap for three consecutive months will be switched to the Sprint Business Flex with All Calls All Day (Section 13.3.4) service offering, unless Customer notifies Sprint otherwise.
