

35. SPRINT BUSINESS ADJUSTABLE RATES PLAN\*

1. Description

The Sprint Business Adjustable Rates<sup>SM</sup> Plan is designed to meet the communications needs of small business customers. Dial-1, toll free and Switched Data Services (SDS) are available. A customer will also have access to Directory Assistance and operator services.

The interstate Dial-1 rate, which a customer is charged each month, will be determined by the customer's total monthly long distance usage. For a monthly recurring charge, a customer may subscribe to a discounted international Dial-1 rate plan. A customer who subscribes to this service is required to receive their bill from Sprint.

The business rates for the Presubscribed Line Charge and the Carrier Universal Service Charge will apply. In addition, other taxes and fees may apply.

2. Minimum Usage Charge

When a customer has less than \$25.00 in total monthly long distance usage, they will be assessed the difference up to \$25.00.

3. Interstate Usage Rates

The interstate full minute usage rates found in this section are billed in 6-second increments with a 18-second minimum.

1. Dial-1

Dial-1 interstate services are available to customers in the U.S. Mainland, Hawaii, Puerto Rico, and the U.S. Virgin Islands. Interstate calls may terminate to a state, U.S. possession or territory that is different from the originating location. Terminating locations include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands, unless otherwise specified in Schedule No. 11.

2. FONCARD

FONCARD interstate service is available from the U.S. Mainland, Alaska, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands. Interstate calls may terminate to a state, U.S. possession or territory that is different from the originating location. Terminating locations include the U.S. Mainland, Alaska, American Samoa, CNMI, Guam, Hawaii, Puerto Rico, and the U.S. Virgin Islands, unless otherwise specified in Schedule No. 11.

A \$1.40 per call surcharge applies to international FONCARD calls.
