13. SPRINT BUSINESS FLEX^{SM*}

1. Overview

1. Description

Sprint Business Flex services are designed to meet the communications needs of small business customers. The services offer flat rated pricing for Dial-1, FONCARD, Switched Data Service (SDS), SDS toll free, and toll free calling. The number of locations a business has does not affect subscription to a Sprint Business Flex service. Only associated locations which are locations that a customer owns or leases, or which is occupied by a business enterprise in which the customer has an equity interest of twenty (20) percent or more or which is occupied by a franchisee of the customer are allowed to participate in Sprint Business Flex. Directory Assistance and Operator Services are also available.

A customer may subscribe to a non-term, one year, two year or three year term plan. Depending upon which plan a customer chooses, monthly or annual commitment levels may apply. The term plans and commitments for each Sprint Business Flex services are explained in the product's section.

2. Access Options

Sprint Business Flex services offers switched access options (including Dial-1 and FONCARD) as described in Section 3.1.2 [Business Communications and Miscellaneous Services](#), Dedicated access options, described in Section 3.1.2, are available to Sprint Business Flex 500 Advanced customers.

3. Billing Increments

Unless otherwise stated, Dial-1, FONCARD, SDS, SDS toll free and toll free calls are billed in 6-second increments with a 18-second minimum. Toll free calls originating in Canada are billed in 6-second increments with an 18-second minimum. All other international calls are billed in 6-second increments with a 30-second minimum.

4. Rate Periods

Rates apply 24 hours a day, every day.

5. Minimum Commitment Levels

Various types of usage contribute towards a customer's minimum annual or monthly commitment.

Contributory usage charges are aggregated across Digital Subscriber Lines, outbound, toll free, switched data services, toll free switched data services, FONCARD (including FONCARD surcharges), EarthLink Sprint Internet Access services, Sprint International Access (Sprint Express), including all calling options, all locations and all jurisdictions (intrastate, interstate and international) in order to meet a minimum annual or monthly commitment level.

* Sprint Business Flex services are no longer available to new customers.

5. Minimum Commitment Levels (Continued)

Feature charges (including installation and monthly recurring charges), Sprint-provided customer premise equipment monthly recurring rental charges or purchase priced, Directory Assistance per call surcharges, Operator Service per call surcharges, Access Coordination Fee (dedicated access only), Central Office Connection Fee (dedicated access only), and T-1 Access Facility charges, calculated before all available discounts have been applied, are also contributory to minimum monthly and annual commitment levels.

6. Termination Liability and Term Plan Renewal

If a customer terminates their one-year, two-year or three-year plan a Termination Liability may apply.

A term plan will automatically renew for an equivalent term and minimum commitment level unless the customer or Sprint provides written notification to cancel the plan. The notification must be received at least 45 days prior to the expiration of the term.

1. Monthly Recurring Charges (MRCs) for Toll Free Service

2. Monthly Service Charge

If a customer does not meet their monthly commitment, a Monthly Service Charge may apply.

3. Surcharges

1. FONCARD Surcharges

In addition to the usage rates, a per call surcharge will apply to FONCARD calls. A per call surcharge applies to International Access (Sprint Express) FONCARD and collect calls. A per call surcharge applies to country-to-country calls. Applicable surcharges are found in each product's section herein.

2. Operator Services

Operator Services is available for interstate and international. In addition to the applicable per minute usage rates for interstate calling the State-to-State Operator Services Per Call Placement Charges and Surcharges apply. In addition to the applicable per minute usage rates for international calling the International Operator Service Per Call Placement Charges and Surcharges apply. See the applicable rates under [Currently Offered Basic Service](#).

Usage will be aggregated across Sprint Business Flex outbound, toll free, switched date services, toll free switched data services, FONCARD (including surcharges) and EarthLink Sprint Internet Access services, including all calling options, all locations, all jurisdictions (intrastate, interstate, and international) and all time of day calling periods for determining the volume discount threshold and eligibility for volume discounts. Feature charges (including installation and monthly recurring charges), Sprint-provided customer premise equipment monthly recurring rental charges or purchase price, Directory Assistance per call surcharges and Operator Service per call surcharges are contributory to the volume discount threshold and are eligible for the application of volume discounts.

Taxes, Presubscribed Line Charges, Carrier Universal Service Charges and any other similar fees are neither contributory to nor eligible for these volume discounts. The customer's employees' Sprint Business Flex usage charges at up to 10 satellite locations (e.g., from home) will contribute to and be eligible for these volume discounts.

8. Termination Liability

Sprint Business Flex 500 one-year and two-year term customers who terminate their Sprint Business Flex Services prior to fulfilling their term commitment will be assessed a termination liability in the amount equal to the minimum monthly commitment level multiplied by the number of months remaining in their term.

The termination liability will be billed in one lump sum. Customers will not incur a termination liability if they: 1) agree to sign a new term plan agreement for a period equal to or greater than the time remaining in their current term plan and 2) commit to a minimum monthly commitment level equal to their current minimum monthly commitment level.
